

1 General information

These instructions contain important information to protect you from injury and prevent damage to the appliance. Please read these instructions carefully before installing or using the appliance for the first time.

Other documents apply alongside these instructions. Please by all means adhere to all documents that form part of the scope of delivery.

Assembly, installation and commissioning must always occur in line with national laws, regulations and standards. The work must be performed by qualified specialists who know and comply with the additional regulations of the local energy supply companies. All safety and warning information as well as the handling instructions in the accompanying documents must be observed.

Please keep these instructions in a safe place and pass them on to the next owner where applicable.

1.1 Validity of the operating and installation instructions

These instructions apply to several appliance versions. It is therefore possible that some of the features described do not apply to your appliance. The details of the figures contained herein may differ from some appliance versions and are to be understood as schematic diagrams.

1.4.1 Safety and warning instructions

The safety and warning instructions in this manual are emphasised with symbols and signal words. Safety and warning instructions are structured as follows:

The appliance complies with the stipulated safety requirements. The user is responsible for the safe use of the appliance, cleaning and maintenance. Improper use can lead to personal injury and damage to property.

2.1 Intended use

The appliance is solely intended for general lighting in private

This appliance is not intended for:

- professional use
- outdoor use
- heating rooms
- use in mobile installation sites such as motor vehicles, ships or
- use at altitudes of over 2000 m (metres above sea level)
- use when not fully installed

Any other use or any use that goes beyond that which is described here is classed as unintended.

BORA does not assume any liability for damages caused by incorrect installation, improper use or incorrect operation.

All misuse is prohibited!

2.2 **Security instructions**

DANGER

Risk of injury from incorrect assembly

Failure to observe the installation instructions can lead to injury.

- ▶ The appliance must only be installed and assembled by trained specialists who are familiar with and comply with the standard national regulations and supplementary regulations of the local utility companies.
- ▶ The appliance may only be installed with the power disconnected.
- ▶ Work on electrical components must only be conducted by trained electrical personnel.
- Conduct all work extremely attentively and conscientiously.
- ▶ Before handing the appliance or system over to the end user, ensure that it has been correctly installed.

CAUTION

Dazzle risk from bulb

Looking directly at the bulb can lead to vision disorders and eye irritation.

▶ Do not look directly at the light.




Fig. 3.1 Appliance dimensions




Fig. 4.1 Horizon appliance description

Installation 5

Scope of delivery 5.1

Checking the scope of delivery

- ▶ Make sure the delivery is complete and check it for damage.
- ▶ Immediately notify the BORA Service TeamTeam if parts are missing or damaged.
- ▶ Do not under any circumstances install parts which are damaged.
- ▶ Dispose of transport packaging in the proper manner (see "8 Decommissioning, disassembly and disposal").





Fig. 5.1 Installation inclination


5.3 Installing the light

▶ Preinstall the attachments according to the installation template.



Installation with drilling template

• The attachments must not be fully screwed in.




Preinstall the attachments

▶ Remove the cover.



The cover is held on by magnets. Hold the controller housing by the opening on the back to lift the cover.

▶ Position the light so that it is held by the keyholes.




Fig. 5.5 Position the light

► Screw the light tight to the ceiling.




Fig. 5.6 Attach the light

- ▶ Remove the two screws on the cable reel.
- ▶ Slide the cable reel to adjust the light fixture horizontally.




Fig. 5.7 Remove the cable reel and position it

- ▶ Reattach the cable reel using the two screws.
- ► Connect the lights to the terminals.




Fig. 5.8 Connection terminal

- ► Fit the cover using the magnetic holders.
- Ensure that the cables are not trapped by the cover.




Fig. 5.9 How to fit the housing

6 Operation

6.1 Gesture control

If there are any issues operating the gesture control, it may help to switch the direct and indirect operating modes on and off or to unplug the light for a few seconds.

6.1.1 Position and clearance

The gesture sensor for controlling the light is at the end of the light fixture and is marked with the BORA logo. The sensor is activated under the light and when in disconnected mode also above the light. The hand that is making the gesture should be 10 cm at most from the light.




Fig. 6.1 Sensor position

6.1.2 Switching on/off

➤ To switch the light on or off, move your hand under the sensor from front to back.




Fig. 6.2 Switching the light on and off

6.1.3 Changing the colour temperature

To change the colour temperature, swipe your hand across the sensor from side to side. The colour temperature can be changed in 4 intervals from 2700 K (warm white) to 5000 K (cold white). Swiping towards the light makes the light colder; swiping away makes the colour temperature warmer. When changing the colour temperature by several intervals, ensure you move your hand back outside the sensor detection zone.




Fig. 6.3 Changing the light temperature

6.1.4 Dimming

To dim the light, you must hold your hand under/over the sensor; this allows the light to be seamlessly dimmed from 2 to 100%. When the desired amount is reached, the light will flash once.




Fig. 6.4 Dimming gesture control

6.1.5 Connecting direct/indirect mode

To disconnect/connect the indirect lighting from/to the direct lighting, the sensor must be operated from above and below (BORA recommends making a C-shape with your hand). If the command is detected, the lights will flash twice. If disconnected successfully, the indirect lighting will be switched off.




Fig. 6.5 Connecting/disconnecting lights

The indirect and direct lighting can now be operated separately.




Fig. 6.6 Indirect lighting control




Fig. 6.8 Height adjustment




Fig. 6.7 Direct lighting control

When both parts of the light are connected, the direct lighting settings are adopted for the indirect lighting. The light is simply controlled more using the lower sensor.

6.2 Operation following a power cut

In the event of a power cut or if the light is disconnected from the mains (e.g. light switch), the current status (dimming status, light temperature, etc.) is saved beforehand and is restored after the power cut.

However, if the light is off when the power goes off, the light will come back on afterwards on the lowest light setting. Switching the light off and back on again will restore the settings that were saved before the power cut.

6.3 Height adjustment

The height of the light can be seamlessly adjusted at any time. Simply pull the light down or up to the desired height.



A minimum clearance of 65 cm must be maintained between the surface to be illuminated below the light and the light fixture.

7 Cleaning and maintenance

The bulb on this light cannot be replaced. When the bulb reaches the end of its service life, the whole light must be replaced.

The appliance does not require any maintenance; however, it should be cleaned regularly.

7.1 Cleaning

- ► Clean the appliance regularly.
- ► To clean it, use a cloth slightly dampened with water.

8 Decommissioning, disassembly and disposal

- ▶ Observe all safety and warning information (Safety).
- ▶ Follow the enclosed manufacturer's information.

8.1 Decommissioning

Decommissioning refers to ultimate decommissioning and disassembly. Following decommissioning, the appliance can either be installed in another unit, sold on privately or disposed of.

- The electricity connection may only be disconnected and cut off by certified specialists.
- Switch the appliance off before decommissioning (see operating instructions)
- ▶ Disconnect the appliance from the power supply.

8.2 Disassembly

To be removed, the appliance must be accessible for disassembly and disconnected from the power supply.

- ▶ Remove any housing parts that can be dismantled.
- ▶ Remove the installation aids.
- ▶ Remove the appliance.
- ▶ Dispose of the old appliance and any soiled accessories as described under "Environmentally-friendly disposal".

8.3 Environmentally-friendly disposal

8.3.1 Disposal of transport packaging

The packaging protects the appliance from damage during transport. The packaging materials have been selected taking into account the environment and their disposal and are therefore recyclable.

Recycling the packaging saves raw materials and reduces waste. Your specialist retailer will take the packaging back.

- ► Give the packaging to your specialist retailer
- ▶ dispose of the packaging correctly observing regional regulations.

8.3.2 Disposal of the old appliance



Electrical appliances with this mark must not be disposed of in the household waste at the end of their service life. They must be disposed of at a collection point for the recycling of electrical or electronic appliances. Information on this can be obtained from the city or local councils.

Waste electrical and electronic appliances often still contain valuable materials. However, they also contain harmful substances that were necessary to make them work and ensure their safety. If placed in the household waste or handled incorrectly, they may harm human health and damage the environment.

- ▶ Never dispose of your old appliance in the household waste.
- ▶ Take the appliance to a regional collection point for the return and further processing of electrical and electronic components and other materials.

9 Warranty, technical service, spare parts, accessories

▶ Observe all safety and warning information (Safety).

9.1 BORA manufacturer's warranty

BORA provides its end customers with a 2-year manufacturer's warranty for its products. The end customer is entitled to this warranty in addition to the statutory claims for defects against the sellers of our products.

The manufacturer's warranty applies to the BORA products listed here, which are sold by authorised BORA retailers or by BORA trained salespersons and are installed within the European Union (overseas territories excluded), Switzerland, Liechtenstein, Ukraine, Russia, Norway, Serbia, Israel, UK, Iceland, India, Australia and New Zealand, with the exception of BORA products labelled as universal or accessories:

BORA lighting

The manufacturer's warranty starts as soon as the BORA product is handed over to the end customer and is valid for 2 years. Registering on www.mybora.com enables the manufacturer's warranty to be extended to 5 years.

The manufacturer's warranty requires expert installation (in accordance with the valid BORA ventilation handbook and operating instructions at the time of installation) of the BORA products by an authorised BORA retailer. During use, the end customer is to adhere to the specifications and instructions in the operating manual. When filing a warranty claim, BORA must be directly notified of the fault and the receipt must be presented. Alternatively, proof of purchase can be provided by registering on www.mybora.com. BORA guarantees that all BORA products are free from material and production defects. The defect must exist prior to delivery of the product to the end customer. Filing a warranty claim does not interrupt the warranty period, nor shall the period start anew. BORA will correct defects in BORA products at its own discretion by repairing or replacing the product. All costs for the correction of defects under the manufacturer's warranty shall be assumed by BORA.

Expressly not covered by the BORA manufacturer's warranty are:

- BORA products that were not sold by authorised BORA dealers or salespersons trained by BORA
- Damage caused by non-adherence to the operating instructions (including product care and cleaning). This represents improper use.
- Secondary damage or claims for damages beyond the defect Legal claims, particularly statutory claims for defects or product liability are not limited by the warranty and can be asserted free of charge

If a defect is not covered by the manufacturer's warranty, a claim may be made against the BORA Technical Service.

BORA shall not assume the resulting costs.

The laws of the Federal Republic of Germany apply to these warranty conditions.




